**Important Notes :** 1. The total number of section of the school shall be restricted to 38 (as per prescribed dimension) as per the number of class rooms reported during inspection and further increase shall be subject to specific approval of the Board on the basis of the request of the school as per affiliation bye laws. 2. The school has mentioned the area of land is 8650 sq mt in the application whereas in land document submitted it is 51 Kanal (i.e. approx. 26000 sq mt). Hence the school is required to construct boundary wall of the entire plot as per land document and submit correct land certificate on their school website. 3. IC Suggested: To form PTA and keep it functional, Stock Registers should be maintained properly, Should appoint a special educator, At some places ramps are required, Should install more CCTV cameras for the safety of students. 4. As IC reported, some discrepancies were found during the physical inspection of BRCM Gyankunj School: i) Library books were procured from their sister concern school i.e. BRCM Pubic School, Bahal. ii). Bill details are not found for Labs apparatus and other items and stock registers are to be maintained properly. School is required to resolve the issues. 5. The school is required to appoint more teachers so that the section teacher ratio of 1:1.5 is maintained at all levels. 6. The school is required to renew all the mandatory certificates from time to time. 7. The school is directed not to remove the essential documents uploaded on mandatory public disclosure of the school website and videography link in future.
